INTRODUCTION:

This Emergency Response Plan is prepared in compliance with the 1992 Safe Drinking Water Regulations that were passed pursuant to the *Health Act*, by the Government of the Province of British Columbia. This Emergency Response Plan is to be implemented in the event of an emergency that affects the water system owned and operated by Cobble Hill Improvement District.

PURPOSE:

This Emergency Response Plan is prepared to provide information and guidelines to Trustees that will enable them to respond quickly and effectively to any foreseeable event that may affect the continuous supply of safe water from the Cobble Hill Improvement District water system.

Depending on the nature of the emergency, the applicable plan will be activated. The objective is to ensure a safe supply of domestic water to the residents of Cobble Hill Improvement District.

In an emergency, action to contact those in the chain of command will be initiated by the first person to have knowledge of the situation. Depending on the nature of the emergency, the first person aware of the situation can delegate any other person to contact people in the chain of command. The most senior person who is notified will take command and will be responsible for delegating tasks to others as the situation warrants. If not at the site or available, the Chairman and other Trustees must be notified with details of the event as soon as possible. The Chairman and Trustees will inform the authorities, if required, of the actions taken and will make recommendations to prevent reoccurrence.

AUTHORIZATION FOR ACTION:

Should an emergency occur in either source or supply of water, any two of the above persons so contacted shall be charged with and shall take the appropriate steps necessary to immediately rectify the situation. In undertaking any action to rectify an emergency situation, due regard shall be paid to the following guidelines.

EMERGENCY PROCEDURES:

All Trustees hold a copy of this Emergency Response Plan and keys to the System Control Building, all padlocks, and the control box at the Hutchinson Road Well. A customer list is included in this plan which will be updated from time to time. In the event that an emergency is of a lasting or unsafe nature, the District shall notify by telephone or hand delivered notices, all residents within its boundaries of the emergency situation. If possible, such notice should state actions, which can be taken by the residents and expected time frame for rectifying the emergency situation. Blank copies of the notices are in the office at 1486 Fisher Road, Cobble Hill.

ALTERNATE SOURCES OF WATER:

If the situation involves a contamination of the water source that cannot immediately be rectified to meet safe drinking water standards, the following shall be considered as alternative potable water sources:

Hauling Emergency Water:

- Clean and disinfect all water containers and other equipment with a solution of bleach that is 10 times stronger than the solution used to treat water. In other words, the solution to disinfect water containers is 20 drops of bleach for each L of water. Shake and let stand 30 minutes. Double the bleach if the water is cloudy. For cold water double the bleach again.
- Do not use containers that have held oil, sewage, pesticides or other chemicals.
- Disinfect the supply of hauled water to counteract possible contamination from handling or transporting

Disinfecting Water

Disinfect all water that will be used for:

- Drinking
- Cooking
- Brushing teeth
- Washing dishes and
- Washing fruit and vegetables to be eaten raw

It is especially important to make sure that any water used to make infant formula is disinfected.

Let muddy or cloudy water settle before disinfecting (or, preferably, use a different source of water). Pour off clear water into a separate container before disinfecting. It sometimes helps to filter the water through a clean cloth, after which the following procedures to disinfect should be applied:

Disinfecting Small Quantities of Water

Boiling:

Boiling effectively kills bacteria, viruses and parasites. A two minute full boil is recommended and will provide adequate protection except at very high elevations. At elevations over 200 m (6500 feet), boiling for three minutes will provide protection.

Remove the flat taste by standing the boiled water in a covered container for a few hours, or by pouring the water back and forth from one clean container to another.

Disinfecting with chemical methods:

Household bleach (5% chlorine)

An effective disinfectant which works best with warm water (where water is colder than 15 degrees Centigrade use longer disinfection times

Add 2 drops (0.1 mL) of bleach to 1 L of water; shake and allow to stand for 30 minutes before drinking Double the bleach for cloudy water

For cold water double the bleach again

A slight chlorine odour should be noticeable if you have added enough bleach

Chlorine Tablets

Follow manufacturers' directions

Iodine:

Whenever possible use warm water (20degrees C) and a minimum of 20 minutes mixing time before drinking

For cold water (5 - 15 degrees Centigrade) increase the mixing time to 40 minutes

Use 10 drops (0.5 mL) of 2% tincture of iodine for 1 L of water

For iodine tablets follow manufacturers' directions

Pregnant women should not use iodine drops to purify water as it may have an effect on the fetus.

SYSTEM START UP FROM A SUPPLY FAILURE:

If an emergency occurs which interrupts the supply of water to the District's distribution system that results in the District running out of water, the following procedures shall be followed upon system start up to ensure that the system is not damaged due to air/water pressure build up:


- 1. System start up should be a coordinated effort between a number of individuals and shall not be attempted by one person
- 2. Before water is reintroduced into the system, the standpipes in the lowest portion of the system shall be opened to release air from the system
- 3. Once the lowest line is free of air and closed, the system will back fill with water and air will be systematically released from the various standpipes. This should be a coordinated effort to ensure that no end of the system experiences a build up in air pressure

PROCEDURE TO START HUTCHINSON ROAD WELL:

When turning on the Hutchinson Road well for the first time after winter break the following procedures should be followed:

- 1. With all valves closed, open # 1 and #2 valves
- 2. Switch pump breaker to on position
- 3. Using valve key slowly open #3 valve. This will increase flow out of #2 and backflush #3 valve out standpipe.
- 4. Working back and forth close #2 and open #3 fully
- 5. Pump can now be operated when needed

Note: Take a water sample and make sure results are satisfactory before putting well back on line after winter layoff.

BOIL WATER NOTICE

The Cobble Hill Improvement District, in consultation with the Vancouver Island Health Authority, has issued a **Boil Water Notice** for the Cobble Hill Improvement District. This Notice is effective immediately and covers all Cobble Hill Improvement District customers in Cobble Hill and those who obtain water from any secondary distributors that receive water from the water system.

Until further notice, water from Cobble Hill Improvement District should be held at a rolling boil for one minute and cooled before it is consumed. For your safety, only boiled or bottled water should be used for drinking, making ice or fountain drinks, washing dishes, brushing teeth, or preparing foods that will not be cooked.

Recent water tests show the presence of unacceptable level of bacteria. Boiling the water will make it safe to drink.

Turbidity in the water system has risen to unacceptable levels. High turbidity can interfere with disinfection and may signal the presence of disease causing organisms. Boiling the water will make it safe to drink.

The water system recently experienced a

possible source contamination

which may have made the water unsafe to drink. Boiling the water will make it safe to drink.

The Cobble Hill Improvement District and the Vancouver Island Health Authority are working together to resolve the situation. Once the water is safe to drink, the Boil Water Notice will be rescinded.
